DML VESSELS WITHOUT REQUIRED DOLPHIN SAFETY GEAR

At its 35th meeting, the IRP requested that the Secretariat propose possible measures to reduce the incidence of infractions by vessels with DMLs for not having all the dolphin safety gear and equipment required by Annex VIII.2 (a-e) of the AIDCP, specifically:

Annex IV (III) 5 provides one such measure:

“No vessel may be eligible to receive an additional allocation of DML by a Party unless it has on board all of the required dolphin safety gear and equipment throughout the year...”.

Article XVI (Compliance) of the AIDCP states that each Party shall ensure effective compliance with the Agreement, in particular “through, *inter alia*, an annual certification and inspection program”, that vessels comply with the operational requirements established in Annex VIII.

To ensure that all vessels with DMLs have all the required dolphin safety gear aboard during the entire year, each Party could carry out at least two inspections each year of the gear on each of its vessels with a DML. One such inspection could be required before the vessel’s request for a DML is submitted (October 1 for full-year DMLs, April 1 for second-semester DMLs). An additional inspection might then take place before the notification of any reallocation of DMLs (May 20) for vessels with full-year DMLs, and at some time during the last quarter of the year for vessels with second-semester DMLs.

If the Parties do decide to impose such an inspection requirement, it could be implemented via a resolution or by an amendment to Annex VIII of the AIDCP.
