During the period since the 72nd meeting of the IRP, the Secretariat has reviewed data of 939 fishing trips. Of these, we have two trips with cases of possible non-compliance that the IRP identifies at predetermined form; that is, the Secretariat has been instructed by the IRP to forward them to the Parties for investigation after each meeting. In addition, we have five cases of possible non-compliance that the IRP requires to analyze and provide guidance to the Secretariat during its meeting.

3. 2023990: Vessel with DML without an AIDCP qualified captain:

The fishing trip was conducted with a captain who is not on the List of Qualified Captains by the AIDCP.

4. 2024040: Vessel with DML without an AIDCP qualified captain:

The fishing trip was conducted with a captain who is not on the List of Qualified Captains by the AIDCP.

5. 2024293: **Observer interference**:

The observer was harassed with inappropiate comments and actions by some crew members.
