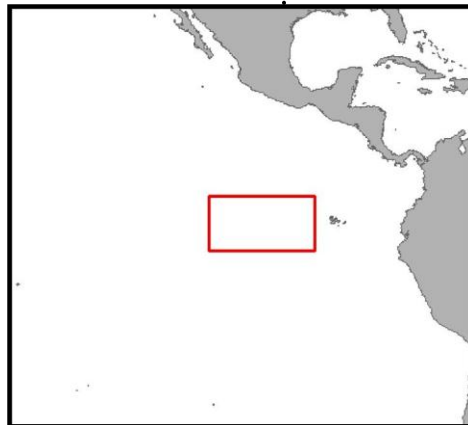


Propuesta similar a IATTC-78-06b

Proposal similar to IATTC-78-06b

- Aplicable para 3 años (2009-2011)
- Cerco:
 - Veda de 12 semanas en el OPO entero (20 Jun – 11 Sep) **demorada 25 días en 2009 (15 Jul – 6 Oct)**
 - Veda del área de alta mar (12 Sep-31 Dic) **acortada 25 días en 2009**



- Applies for 3 years (2009-2011)
- Purse seine:
 - 12-week closure in the entire EPO (20 Jun – 11 Sep) **delayed 25 days in 2009 (15 Jul - 6 Oct)**
 - Closure of offshore area (12 Sep-31 Dec) **shortened 25 days in 2009**

Propuesta–Proposal (cont.)

- Palangre
 - Límites fijos de captura para China, Corea, Japón, y Taipei Chino
 - Capturas por otras CPC limitadas al 83% de sus capturas respectivas de 2001 o 500 t, el que sea mayor
- Longline
 - Fixed catch limits for China, Japan, Korea, and Chinese Taipei
 - Catches by other CPCs not to exceed 500 t or 83% of their respective catches in 2001, whichever is higher

Otras recomendaciones

Other recommendations

- Marcado e identificación de plantados
 - Resolución C-05-02 sobre albacora del Pacífico Norte:
 - Esfuerzo actual = esfuerzo medio de 2002-2004
 - Incluir información sobre esfuerzo de pesca en informes semestrales
 - Incluir datos del OPO solamente en los informes
 - Retención completa de capturas de atún (C-06-03)
- Marking and identification of FADs
 - Resolution C-05-02 on Northern Pacific albacore:
 - “current” effort to be defined by an ad-hoc working group
 - Include information on fishing effort in six-monthly reports
 - Include data for EPO only in reports
 - Full retention of tuna catches (C-06-03)

Resolution C-09-01

purse-seine closures

- 59 days in 2009, 62 days in 2010, and 73 days in 2011:
- 2009 – 1 August to 28 September, or from 21 November to 18 January 2010;
- 2010 – 29 July to 28 September, or from 18 November to 18 January 2011;
- 2011 – 18 July to 28 September, or from 7 November to 18 January 2012.
- 2011 closure subject to ratification

Resolution C-09-01 (con't)

- purse-seine vessels capacity class 4 able to make a fishing trip...
- purse-seine closure in offshore area 29 September- 29 October...
- Longline limits 2009 2010
- China 2,533 2,507
- Japan 32,713 32,372
- Korea 12,073 11,947
- Chinese Taipei 7,635 7,555
- Other countries catch max(500 t, 2001 catch)
- Adjust in 2011 comparable to purse seine

Resolution C-09-01 – other provisions

- in 2010 and 2011, the IATTC scientific staff will analyze the effects on the stocks of the implementation of this resolution and past ones; if appropriate recommend changes to conservation measures
- a pilot program for research into, and gathering information on, the FADs used to aggregate tunas in the EPO...
- Subject to the availability of funding, ... experiments with sorting grids for juvenile tunas and other species of non-target fish in the purse-seine nets...
- require all purse-seine vessels to retain and land (BET, YFT, SKJ) tunas subject to exceptions.
